IMP –1. . All should note carefully Student admitted through Supernumerary Quota seats like **TFWS, GOI, J&K Migrant, JKSSS (PMSSS), EWS, FNS, OCI, PIO, CIWGC** are not eligible for any Change of Course (Branch).

2. Those who have not taken admission for A.Y. 2026 – 27 are not eligible.
